Jim also said he will share the survey results with her. If he decides to write an article based on the results, he will send the draft first to Brown-Miller Communications and UW&GS. It was noted that since this survey, it has become known that Wine Business Communications (owner of W&V) is sponsoring a new industry event with trade show in early December at the Santa Rosa Fairgrounds.
