#### **LLC Managing Committee Meeting Agenda**

- 1. Call to Order. Jim Harbertson called the meeting to order at 12:29 pm.
- 2. **Approval of January 26 Meeting Agenda.** Bill Pauli moved to approve the January 26 meeting agenda, second by Tom Slater. Motion was approved.
- 3. **Approval of January 9 Meeting Minutes.** Mike Boer moved to approve the January 9 meeting minutes, second by Tom Collins. Motion was approved.

#### 4. New Business

- a. **Unified Budget: Catering Budget Overage.** Dan Howard provided an update on the 2023 Unified budget. He stated that when we budgeted for the overall catering, the number was based on the 2022 Unified final catering number, instead of the 2020 Unified. Catering was budgeted at \$19,000 and it should be budgeted at \$34,000, therefore there will be an overage on the final budget.
- b. **2023 Program Development Committee Chair Brief Discussion.** Natalie Collins and Jenny Devine provided an update on the 2024 Unified Program Development Committee. The chair position is a two-year rotation and Alisa Jacobson is willing to serve once again, Leticia Chacon-Rodríguez will be moving off, and we need to find the second person. The committee discussed the importance on finding someone who is motivated and has the energy, who has the connections and who can help move the program along on the timeframe provided. In the past, we have had a representative from both the winemaking and grapegrowing, which balanced out the contacts and knowledge areas.

We will hopefully open up to exhibits in Ballroom B in 2024.
