Call to Order. The LLC Managing Committee meeting was called to order at 10:00 AM by Jim Kennedy.

Approval of Agenda. Jim Kennedy moved to approve the agenda as submitted. Second by Tom Collins. Motion was carried.

Approval of January 30 Meeting Minutes. David Weiss moved to approve the minutes as submitted, second by Carson Smith. Motion was carried.

Old Business

• Updated 2014 Registration Report

- There were 400 total more people registered than last year. The onsite marketing number was 14,000, but the actual overall number was 13,800. Such a variance is standard and is typically due to duplicates and other anomalies. The incorrect exhibitor staff count was in the last report provided at the January meeting.
- John Aguirre asked how the increased revenue associated with the higher attendance is in comparison to the increase in the advertisement budget. Lyndie noted that this is not a metric that we can directly tie together. She added that Mike Miller has previously confirmed that exposure and how we are perceived is of value.
- o There was an increase in non-member registrants. The Unified registration fee is competitive with other events, especially for conferences within the finance and marketing sectors.
- The comp registrations increase was due to the addition of speakers to the report.
- o There was a decrease in exhibit only registrations.
- The Keynote Luncheon had a total of 288 registrants, a positive first start.
- Session attendance is on the rise and the overall symposium attendance has been growing each year.
- Revisit the Welcome Reception Time. The LLC Managing Committee agreed to adjust the time, to begin at 4:30 PM and end at 6:30 PM. The breakout session will need to end at the Sheraton at 4:00 PM, because the staff will need 30 mins to set for the reception. All three ballrooms will be needed if we open the welcome reception to all exhibitors. We do need to keep the flexibility with the breakout sessions (don't understand this sentence keep schedule flexibility or meeting room assignment flexibility?).



- Review and Approve the 2015 Symposium Schedule.
 - LLC Member Welcomes at General Sessions. Historically, the introductions rotate from year to year between Tuesday and Wednesday. The ASEV chair will do the introduction on Tuesday, John Aguirre will now do the introduction on Wednesday, Tom Collins, as PDC chair, will still do the introduction on Thursday.

Keynote Luncheon Speaker.

- The LLC Committee has decided to invite Francis Ford Coppola back as keynote speaker. However, a strict deadline will need to be enforced. If Mr. Coppola is not available to speak, the committee has time to invite another speaker.
- Additional Speaker Suggestions. The committee identified 6 additional speakers and ranked them in order (additional information and the ranking took place after the meeting, via email):
 - 1. Alton Brown. Alton Crawford Brown an American television personality, celebrity chef, author, actor, and cinematographer. He is the creator and host of the Food Network television show Good Eats, the mini-series Feasting on Asphalt and Feasting on Waves, and host and main commentator on Iron Chef America and Cutthroat Kitchen. Brown is also the author of several books on cookery. He brings a knowledge and enthusiasm for the science of cooking and food and a humorous approach to his shows. In October 2013, Alton launched "Alton Brown Live: The Edible Inevitable Tour," his first national tour visiting 45 cities through March 2014. The show includes stand-up comedy, talk show antics, a multimedia lecture, live music and "extreme" food experimentation.
 - 2. Michael Chiarello. Michael Chiarello is an American celebrity chef specializing in Italian-influenced California cuisine. He hosts the cooking show, Easy Entertaining with Michael Chiarello, on the Food Network and hosts NapaStyle on the Fine Living Network. Chiraello owns a winery, Chiarello Family Vineyards, Bottega Ristorante in Napa Valley, NapaStyle, a purveyor of food, cookware, and furniture, and a competitor on the fourth season of The Next Iron Chef, where he placed as the second runner up. In spring 2013, Michael arrived at San Francisco's waterfront with his latest restaurant, a Spanish concept on Pier 5.
 - 3. **Guy Fieri.** He is an American restaurateur, author, television personality, and game show host. He co-owns five restaurants in California and is known for his television series on the Food Network. Guy Fieri purchased a five acre vineyard of pinot noir grapes in Sonoma County, and has plans for organic farming techniques, opening a tasting room, and using "the grounds to educate children about cooking".
 - 4. **Jimmy Russell.** Master Distiller James C. Russell, or Jimmy to anyone who has ever shaken his hand, has been making bourbon in Lawrenceburg, Kentucky at the Austin, Nichols Distillery for 54 years. Growing up just five miles from the distillery, Jimmy followed in the footsteps of his father and grandfather, learning time-honored traditions and techniques uniquely suited to the heart of bourbon country.



- 5. T.J. Rodgers. T.J. Rodgers is founder, president, CEO, and a director of Cypress Semiconductor Corporation since 1982. He is a former chairman of the Semiconductor Industry Association (SIA) and SunPower Corp. (solar energy systems) and currently sits on the board of directors of high-technology companies, including Agiga Tech (nvRAMs), Bloom Energy (fuel cells), and Cypress Envirosystems (energy-saving systems). He is a Trustee Emeritus of Dartmouth College, his alma mater. He is also the owner and winemaker for Clos de la Tech. He has been making wince since 1996.
- 6. Elon Musk. (Was not officially ranked, keep on the list for further discussion if needed): Elon Musk is an engineer and entrepreneur who builds and operates companies to solve environmental, social and economic challenges. He co-founded PayPal and currently drives strategy, development and design at two companies he created, Space Exploration Technologies (SpaceX) and Tesla Motors, and oversees a third company, SolarCity, which he co-founded. He led SpaceX's efforts to be the first private company to successfully launch and dock a spacecraft with the international space station.

Action Items

- Reach out to Francis Ford Coppla Task: John Aguirre to reach out to Corey Beck via email, using the same invitation as last year and cc'ing Lyndie Boulton. Ask Corey what he feels is an appropriate deadline – possibly May 1.
- Provide a detailed list of back-up speakers identified by end of March. Task: Jenny Devine-Smith.

o Thursday's Schedule.

- Change the Marketing & PR/Business & Operations at 1:45 PM 3:45 PM.
- The Spanish General Session will be extended until noon. There is a chance that the session will need to move to the convention center, due to the space availability at the Hyatt.
- There is still an issue with space on Thursday with the Spanish track and the Thursday General Session. If the session gets the numbers, the rooms will be too small. There is a possibility to host the Thursday General Session at the Sheraton, then the Spanish General Session at the Hyatt. It will depend on the Sheraton's availability and the number of attendees the room can hold with the set-up and A/V.
- It will be helpful to show the Program Development Committee the meeting room specs when planning each session.
- <u>Action Item</u>: Look at the Sheraton's availability and if they will waive their meeting space fee. <u>Task</u>: Lyndie Boulton

Exhibit Hall Tours.

- The LLC Managing Committee discussed the importance of the tour leaders. There needs to be more guidance at the Program Development Committee level, ahead of time to insure identifying topics that are reflected in the trade show and for the tour stops to be evenly distributed throughout the trade show locations.
- A list of exhibit booths/vendors should be provided at the first PDC meeting and the committee will need to discuss the tour leaders. Hand picks the tour guides, instead of word of mouth. Chik Brenneman offered be a tour leader for winemaking once again.
- If the content is there, we can add on one or two more tours within each track.



- Revisit the Wednesday State of the Industry Speaker Line-Up.
 - Speaker Line-Up.
 - Plan A: Move forward with confirming the same line-up as 2014: Francesca Schuler as moderator, Mike Veseth, Nat DiBuduo and Jon Fredrikson.
 - Plan B: There is still a concern with building in a transition if Jon is not able to come back to speak. If Jon is not available to speak, look at expanding Mike Veseth and Francesca Schuler's speaking role and bring in a new moderator. Potential moderators would include Glenn Proctor or Steve Fredricks.
 - John Aguirre will reach out to Jon Fredrikson regarding his interest and availability.
 - What parts of Jon's presentation is most proprietary; his overall content will be very hard to reproduce.

Timeline.

- The LLC Managing Committee felt that Jon's presentation was a little rushed and discussed how we can keep this from happening in the future. Better time management.
 - The moderator needs to be in control of the time, it was Francesca's first time moderating the SOI session and this can be discussed further if she agrees to once again moderate.
 - A lighting system can be used to notify the speakers on time.
 - The time allowed per speaker can be included in the program.
 - Allocate transition time between each speaker. Listen to the tapes to see what the
 transition time was, it may be a total of an extra 15 mins that needs to be added, 3
 mins per speaker possibly.
 - Look at the 11:00 AM hard deadline of the SOI. Look at moving the press conference to 11:15 AM or 11:30 AM.
 - Start with how many minutes Jon should have and then working backwards.

- Reach out to Jon Fredrikson. Task: John Aguirre
- Proposed 2015 Program Development Committee List. Jenny Devine-Smith provided a list of potential PDC members that both CAWG and ASEV developed. Tom Collins stated that it would be helpful to identify some potential members within the first 5 7 years of their career, to bring a new and fresh perspective. The LLC Managing Committee provided feedback within each session track, the list was identified and Jenny discussed the dates with Tom. Jenny will organize the list, finalize it and will begin to invite the members and request availability.

New Business

• Upcoming Contracts.

- Freeman –Trade Show Contractor/Decorator–plan to renew another 3 years with Freeman.
 Freeman has been wonderful to work with. The committee agreed and had no further questions.
- The Pulse Network (TPN) Event Management Review January 2015. Lyndie Boulton stated that there have been some issues with TPN. She would recommend keeping the online registration and trade show management responsibilities with TPN, but She and Dan would prefer finding another company to handle the other operational responsibilities if possible. or Alternatively, they recommend adding even more specific criteria within TPN's next contract. It is not an issue of non-performance; it is the degree of performance in being managerial rather than just completing tasks



that we manage. They currently do not have other event contractors identified who would be better and they will continue to look for alternative solutions. In the meantime, they will review their contract very carefully and share with the LLC Managing Committee the next steps when determined.

Zepponi & Company's Involvement in Unified & Other Potential Issues/Complaints.

- The LLC Managing Committee reviewed the list of issues Zepponi & Company provided to Bill Pauli.
 The relationship with Zepponi & Company is very important, as it is with all vendors and attendees.
 - Overview: Zepponi & Company did a good job communicating their concerns. All concerns provided, with the exception of the signage, are business as usual. Similar comments have been made across the board with others who have not understood aspects of online registration.
 - Signage/Sponsorship: John Aguirre, Lyndie Boulton, Dan Howard and Jenny Devine-Smith will work together to develop an acceptable response to the signage that was missing onsite. This is the second time within 20 years that a benefit has been missed, it was a simple mistake made by Freeman. The partners will work with Zepponi & Company to provide an equitable offset for the missed benefit.
 - Speaking on the Unified Program Platform: The Unified receives many requests each year to provide speakers with suggested session outlines. This is particularly common from industry suppliers. There is a standard response to all those who provide a proposal that thanks them and notes if the topic is chosen their proposal will be kept in mind by program organizers.
 - Registration: Lyndie Boulton and Dan Howard looked into the accounting records, the registration records and with TPN, and they do not show where the issue was. The issue may have been that they did not fully complete the registration online. Dan and Lyndie noted that to provide a proper response, it would be necessary to speak with the admin person who actually registered their group to obtain all the facts Dan suggested we offer assistance with registration to all sponsors proactively in the future. Everyone concurred this would be a good approach.
 - The Members' staff will work out a solution for Zepponi & Company.
- Carson Smith stated that he overheard a few exhibitors and sponsors having similar issues with online registration. He also had an issue with online registration for adding the lunch. It just seemed that there were more issues this year than year's past. Lyndie Boulton has asked to please share any complaints or issues that may occur during the symposium so that a proper response can be prepared and/or we can evaluate any areas of improvement for the future.

Next meeting dates/times. The next LLC Managing Committee meeting will take place via conference call, on Tuesday, April 22 at 10:00 AM.
