#### **LLC Managing Committee Meeting Agenda**

- 1. Call to Order. Aaron Lange called the meeting to order at 3:04 PM.
- 2. **Approval of April 16 Agenda.** Dan Howard requested amend the agenda to add State of the Industry to New Business. John Aguirre moved to approve the agenda as amended, Tom Collins second. Motion was approved.
- 3. **Approval of March 26 Meeting Minutes.** Lise Asimont moved to approve the March 26 meeting minutes, Nichola Hall second. Motion was approved.

#### 4. New Business

- a. State of the Industry Speaker.
  - i. Dan Howard would like to discuss the 4<sup>th</sup> speaker.
  - ii. When the committee hosted this discussion last year, Tom Collins stated that this position was meant to rotate. He felt that someone from the on-premise world would be a good fit.
  - iii. John Aguirre asked if it would make sense for the Program Development Committee to discuss this 4<sup>th</sup> speaker, they would have a few good ideas on on-premise.
  - iv. This will be a carryover to the next LLC Managing Committee conference call agenda. Members from LLC can send in names for suggestions and float this idea out to the PDC.

#### 5. Old Business

- a. 2019 Keynote Luncheon Speaker Discussion.
  - i. John Aguirre spoke to a few CAWG Board of Directors, to see what type of speaker they would want to see. They stated that they would be interested in seeing another industry leader's perspective. One company that we did not think about was Treasury Wine Estates, Michael Clarke, CEO, their comeback story. Experiences and success.



- ii. Nichola Hall. We are working hard to look for the best speaker for the podium taking slightly less of an initiative than what the audience expects from us. We have had several larger distributors at the podium, which is great, but do we feel that they would give an honest and open presentation to our audience.
- iii. Tom Collins. He would prefer to move forward with a company that keep a better track record. Diedre Mahlan, President of North America Diageo, since 2015. She was in the UK previous to that. It would be a great opportunity to hear from someone who is in the alcohol industry, not directly with the wine industry just yet, but with the knowledge. Another suggestion would be Debora Brenner.
- iv. What are we doing for the next generation? What are we doing to attract the younger generation to our program? We want to make sure we are appealing with the younger generation.
- v. The final decision is to continue to review the other speakers, whittle the names down a bit more, and reach out to Marvin Shanken with Wine Spectator. Tom Collins is working on contact information for Marvin Shanken.
- b. 2019 Program Development Committee Vice Chair. Tom Collins gave an overview of where we left off on the next call with regards to the PDC Vice Chair. Nichola Hall is happy to support Tom Collins in a successful 2019 program and help support for the 2020 program with the transition. Tom Collins moved to approve Nichola Hall as the 2019 PDC vice chair, John Aguirre second. Motion was approved, Nichola Hall abstained from the vote.
- c. **Update on Sacramento Convention Center Construction and Renovation.** Additional 40,000 sq. ft ballroom is now a part of Phase 1. They are in the design phase currently. Construction will begin in January 2019, but will not impact our show, and the convention center will close in June 2019. It is set to open in November/December 2020. CalExpo is holding space in 2021, but there is an issue with the Hyatt. **Next Meeting Agenda:** Discuss space and what events will be held where, to assist with releasing space.

RE 2020 Unified Facilities and Programming

The Managing Committee agreed to hold the 2020 Unified at the Cal Expo, located at 1600 Exposition Blvd, Sacramento. CalExpo is 4.5 miles from the Sheraton Grand, a 12-minute drive without traffic and up to 20 minutes during rush hour traffic. Unified attendees may drive to CalExpo or take shuttle from the two downtown hotels, Sheraton Grand and Hyatt Regency.

The committee needs to determine whether all Unified events, regularly scheduled for Tuesday thru Thursday, will take place at the CalExpo or whether some or all Tuesday events will remain in downtown Sacramento at the Hyatt and Sheraton hotels.

Specifically, the committee should determine the following:

- Location of Keynote Luncheon and afternoon sessions downtown Sacramento or CalExpo.
- 2. Location of Welcome Reception downtown Sacramento or CalExpo.

The following lays out the pros and cons of each choice.
